Andy stated that Domestic Abuse reports had risen sharply since Covid also online Scams.

BIG PLAN –actions were reported as on trackwith the addition of 3 new action colours:

BLUE CIRCLE between red and green (in progress) WHITE CIRCLE not started as yet also a big arrow (WORK -to be completed on time).

Definition "ONGOING" has been removed from the plan as too ambiguous and vague.

To be added to Plan section on Domestic Abuse and Hate Crime which denotes showing engagement with people.PT said within his range of work there were definite concerns with Domestic Violence but Hate Crime was not so prolific for now at least.

GG raised the point on Mental Health and Homelessness what was happening in these areas update next meeting perhaps.

Andy went on to explain CUCKOOING –WHERE Drug dealers take over a vulnerable persons home to deal and store drugs.

SAFE PLACES: 127 places across BCP website has listings which include out of hours.

Andy to speak to Hotels getting them onboard. Christchurch are short on numbers.

Action for PFF to check all listings as numbers could vary due to Covid and places no longer trading

PFF ARE NOW PART OF THE National Safe Places Network.

PT HAS FUNDING TO CONTINUE HIS JOB FOR THE NEXT 2 YEARS FROM Police Commissioner.

Brian Langridge deals with Violent Challenging Behaviours.AW to send amended copy out.

Witness Profiling –PT job is to ensure those with LD feel safe in Court and can give evidence as a Victim or Witness and they fully understand the process.

Ages of cases vary 16-70 age range. Moreso work in 40-50's at present (THEFT /FRAUD).

However these are crossing over to ASBO BEHAVIOURS.

Kimberley is doing online training for next meeting in Nov.

Safeguarding has a new Chair Sian Walker.

Harry's Action Board is nearing completion I look forward to seeing that piece of work.

AOB – Poole Bus Station behaviours had improved due to the Special Officers patrolling there.

MR raised the point on what was the latest on the Safe Places in the Bus Station where I asked in writing to Andy ¾ yrs ago about a room in the new plans? At present all work is on hold.For the interim BCP will put up new signage yet again.

PCT fingers crossed will be at the HATE CRIME event in October to be held in the Centre.
