Went straight into ACTION LOG: 2 outstanding were re LEDER numbers currently BCP are no2 out of 7 areas in South West.No comparisons with the whole of England however.

MR said PCT would send new link out to parents for my life my home booklet.

At present housing are behind schedules and consultations need to take place with the Providers.They will need to include listings of new builds not BCP funded also what funding they are bringing to the table.Finance follow up is in another dept?

Plans in individuals living to have their own tenancies.

Those with ALD if they go into residential homes may come into Supported Living which in turn links to a Housing Association.

TRANSFORMING CARE: is for those requiring specialist Housing which has to be appropriate and Community based.

HOMES ENGLAND: funding bespoke propertiesfor 24hr support update end of yr.

High Level cover from 14-28 hrs has stringent applications which has to comply with ALD framework.

Housing today assured group that all staff trained in ALD especially those in all areas with face to face contact with the public.

16+ can now have properties under certain restraints(not disclosed).

There was no update on Capital Bids as NHS funding has changed.

NHS want to know are BCP going to still reach their targets without Direct funding?

MR pointed out in Progress Report wrong date also completion of ALD Accomodation Review programme had no deadline just 2024 ? amended to March 2024.

Housing Development Plan (not written as yet) hopefully ensures more housing buildsto meet current requirements.

Needs to be 15 more Shared Lives places –update at next meeting.

Group were assured all ALD training for new staff was underway and refreshers.
