2. Working group update on Local Offer.

E/O stated from the start that TOR needed to be discussed at this meeting did not happen even after repeatedly making requests (ran out of time)

3. LW joined meeting and discussed the work with Stakeholders. There was a co-pro project for AHC plans for 14-25 to encourage uptake. YP had written sample letters to GP stating what would make things easier for them to attend addressing any problems for the surgery. Plan currently out to yp groups with supported signposting.

Parent Feedback AW SWAN –EVENT organised at the ARC Christchurch 1st meeting 14 families 2nd no parents. AW thought word had not got out to the parents. LW simply said not about Quantity but Quality of work.

MR PCT gave feedback on work underway and completed by Forum.

EO explained about the Dorset trials from Ofsted with new ways of working round schools.

New National Keyworker Project which will involve Carers alongside a printed version of Graduated Response and Transitions working within a guidance.

Partnership plan is on Dorset website.

SEND IMPROVEMENT:

VG and SL joined together to feedback on WSOA work.

There is now an additional bandings in schools under review piloting links to programme with Anna FREUD. Use of Mental Health tools in school.

Emphasis there is now a lot of answers to questions in new G.R document (Dorset only)

Values have now been created around Transparency Understanding and further engagements. Meetings have been cancelled and four Leads left. Lots to do but co-pro was referenced HOORAY!

Different Charter now in draft.

Amanda Wheeler will collate and update to Sarah Rempol and Debbie next week.

Base lines in Health Services work continues.... Moving forward currently meetings cancelled and work groups not up to date.

Speech and Language contract has been signed off agreed with financial modelling.

In draft... GR work being produced – audit of plans. L/A priority areas to develop all schools by the end of this term to have understanding of process and standards expected.

First three /four schools launch pilot in October-behind schedule. Sarah L in jnt commissioning group with Julia Cramp looking at Short Breaks mapping governance but lots not linking up together. JC is looking at governance on jnt commissioning as a service.

BCP and others to work alongside CCG CHILD SERVICES.

ICS to meet the needs (linking co-pro workstreams with voices of yp and carers based on individual needs.

Policies on Equipment: Policy to be implemented. Governance to send to S I B. There is a lot more to do.

KP Dorset stated 2 OT's sensory nurse to work on school needs based at Linwood.

James Greenhalgh working on ALL AGE AUTISM(Access training support assessments

Audit tools and referrals).

Overall to empower individuals and increase Parent Support.

Autism Training Prog –PCT delivered.

Tier training 1 launched and Tier 2 in late summer 22.

Support and co-design roles and proposals.

Assessments were used from East Berks link to WSOA work in progress.

Amy B –Family Action Dorset has Tier 1 Neurodevelopmental prog for Professionals.

EO to meet up with Amy.

KP asked where was the access to training CM to send link.

E/O under communications plan NO EDUCATION part to this project made specific from the start and in TOR.

E/O wants work widened to increase awareness understanding and needs to work with families. Communication and Understanding will give independency.

MR if not in place children and yp will suffer stressing out and parents yet again bear the brunt seeking crisis help for the whole family. Have communications to share tools.
